I. Commercial sector

1.1. Circular 44/2025/TT-BCT stipulating the rules of origin of goods in the Agreement on the Establishment of the ASEAN - Australia - New Zealand Free Trade Area issued by the Minister of Industry and Trade on July 7, 2025

This Circular stipulates the Rules of Origin of Goods in the Agreement on the Establishment of the ASEAN-Australia-New Zealand Free Trade Area (hereinafter referred to as the AANZFTA Agreement), as amended by the Second Protocol amending the Agreement on the Establishment of the ASEAN-Australia-New Zealand Free Trade Area (hereinafter referred to as Protocol 2).

This Circular takes effect from August 22, 2025.

Circulars after they expire from the effective date of this Circular, except for the cases specified in Clauses 3 and 4 of this Article:

1.2. Decree No. 205/2025/ND-CP amending Decree No. 111/2015/ND-CP on development of supporting industries promulgated on July 14, 2025

Amending and supplementing a number of articles of the Government's Decree No. 111/2015/ND-CP dated November 03, 2015 on development of supporting industries.

From the effective date of this Decree, activities to support the development of supporting industries before the effective date of this Decree shall continue to be carried out according to the approved contents, programs and plans; projects producing supporting industry products that are enjoying preferential policies under Decree No. 111/2015/ND-CP before the effective date of this Decree shall continue to enjoy the approved incentives.

In case an enterprise has submitted an application for support or incentives before the effective date of this Decree but has not yet been approved by a competent agency, the enterprise shall resubmit the dossier under the provisions of this Decree for consideration and approval as prescribed.

This Decree takes effect from September 1, 2025.

Amending and supplementing a number of articles of Circular No. 33/2018/TT-BCT dated October 08, 2018 of the Minister of Industry and Trade regulating market inspection cards.

Amending and supplementing a number of articles of Circular No. 27/2020/TT-BCT dated September 30, 2020 of the Minister of Industry and Trade regulating the contents, order and procedures for inspection and handling of administrative violations and implementation of professional measures of the amended Market Surveillance Force, supplementing a number of articles as prescribed in Circular No. 20/2021/TT-BCT dated December 10, 2021 of the Minister of Industry and Trade.

Amending and supplementing a number of articles of Circular No. 22/2021/TT-BCT dated December 10, 2021 of the Minister of Industry and Trade regulating the management and use of forms in the inspection and handling of administrative violations and the implementation of professional measures of the market surveillance force.

Amending and supplementing a number of articles of Circular No. 55/2020/TT-BCT dated December 31, 2020 of the Minister of Industry and Trade regulating the reporting regime of the Market Surveillance Force.

Amending and supplementing a number of articles of Circular No. 02/2022/TT-BCT dated January 20, 2022 of the Minister of Industry and Trade regulating codes, professional standards and salary classification for market management civil servants.

Amending and supplementing a number of articles of Circular No. 25/2023/TT-BCT dated November 30, 2023 of the Minister of Industry and Trade stipulating the number of civil servants working at market surveillance agencies at all levels.

Numbers and signboards of civil servants working at market surveillance agencies at all levels issued before the effective date of this Circular may continue to be used until the end of December 31, 2025 or until the time of replacement number issued by the Director of the Domestic Market Surveillance and Development Department as prescribed in this Circular.

Market inspection cards issued to market surveillance officials before the effective date of this Circular but still valid for use may continue to be used until the end of December 31, 2025 or may continue to be used until the expiration of the validity period stated on the market inspection card in case the validity period ends before December 31, 2025.

This Circular takes effect from July 15, 2025.
